**Re: Illinois Freedom of Information Act Request**

Dear Director Sledge:

This is a request for information under the Illinois Freedom of Information Act, 5 ILCS 140.

**I request copies in PDF format on CDs of ALL documentation pertaining to and/or containing information on the following:**

**The IBM Technical Services Program (TSP)**

The planning and execution of the IBM Technical Services Program (TSP). Provide the name(s), professional title(s), project role and affiliation of ALL STAFF including consultants, advisors, SMEs, CMS/Bureau of Communications and Computer Services (BCCS) staff, CMS staff and Governor's Office staff involved in the planning and execution. Also, to include All correspondence, decision memos, project documentation, analysis and documentation showing the staff signatures who signed off to allow the TSP to go into effect. Documents should include screen prints of the BCCS EPM System pages, Remedy System or any other online system or environment which provides details, status and any other related information pertaining to the efforts that lead to the implementation of the TSP. Include the total expenditures per year and per agency during the entire life of the TSP.

**Uniform Price Card (UPC) Project**

The planning and eventual cancellation of the Uniform Price Card (UPC) project. Provide the name(s), professional title(s), project role and affiliation of ALL STAFF including consultants, advisors, SMEs, Bureau of Communications and Computer Services (BCCS) staff, CMS staff and Governor's Office staff involved in the planning, discussion and cancelation of the effort. (Specifically to include correspondence and all other documentation from Greg Wass, Doug Kasamis, Mike Porter, Karl Thorpe and Dianne Breen) Also, to include All correspondence, decision memos, project documentation, analysis and survey details. Include documentation identifying the staff who made the decision to cancel the project. Documents should include screen prints of the BCCS EPM System pages, Remedy System or any other online system or environment which provides details, status and any other related information pertaining to this project.

**Doug Kasamis – State of Illinois affiliations, Job, Title and Salary History**

Provide ALL information pertaining to Mr. Kasamis's interaction with the state as part of Accenture, provide the CMS job title Doug was first hired with CMS as/under including initial salary, all steps thereafter with CMS title and salary details up through 2/12/09. Include all documentation pertaining to Doug's affiliation with Accenture, a company which has been under contract with the state of Illinois during the Blagojevich administration. Include the total of all money paid to Accenture split up by year between 2002 and 2009 and list which agencies Accenture was contracted to. Include all documentation pertaining to Doug's business affiliations with companies formerly or currently under contract with the state of Illinois.

**IT and Consolidation Consulting Contracts**

Provide the totals paid per year to companies for consulting services to the State of Illinois. This list should include but not be limited to Accenture, EKI and BearingPoint and should span the years 2002 through 2009. Also include details as to what services were rendered to the state for the payments.

**Andy Georgopoulos– State of Illinois affiliations, Job, Title and Salary History**

Provide ALL information pertaining to Andy's work interaction with the state, the CMS job title Andy was hired under including initial salary, all steps thereafter with CMS title and salary details up to 2/12/09. Include all documentation pertaining to Andy's affiliations with companies formerly or currently under contract with the state of Illinois.

**Yearly travel, lodging and per diem Expenditures**

Provide the total of all yearly travel, lodging and per diem expenditures for all CMS staff who maintain a permanent residence outside of Springfield in which the state of Illinois has paid for these expenses for staff travel to Springfield or any other location for work. Break these totals out per person by travel, lodging and per diem per year between and to include the years 2002 through 2009. Also include state vehicle rental costs as applicable, if these vehicles were used by CMS staff during the times in question.

**Title and Salary History**

Provide the Title and Salary history by year between the years of 2002 and 2009 for all people who have been in CMS senior staff and management positions – Be it CMS official title or other working title. To include Directors, Deputy Directors, Chiefs of Staff, etc. such as Jay Carlson, Jim Matthews, Tony Daniels, MaryBeth Johnson and Vince Arredondo. Provide details about any other moneys paid to ANY CMS manager or other employee who was on a contract of any kind prior to becoming a state employee.

**Top Salaries**

Provide the names, complete title, salary history and agency worked for the top 300 state employees by salary who have been hired since Jan. 2002. This list should

include those who still work for the state as well as those who have been employed at any time since Jan. 2002.

I request a waiver of all fees for this request. Disclosure of the requested information is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of portions of state government and is not in my commercial interest. The public has the right to know how state funds have been spent, by whom and if sound decisions are being made in the publics best interest.
